## Responsibilities:

- Provide immediate crisis support, safety, reconnection, stabilization, and trauma responsive care services.
- Complete a comprehensive stabilization assessment, identify, and refer needed referrals for basic needs such as food, clothing, mental health services, youth services, cultural services, legal support and medical.
- Provide survivors with appropriate referrals in accordance with individual need.
- Develop individual safety plans to include one social support and two effective coping skills.
- Present options and referrals for safe housing.
- Inform survivors of the options OFP or restraining orders.
- Assist in completing and filing court documents for orders of protection and restraining orders. Assist with contacting child protection, probation and other county services that support survivors.
- Attend and provide support at court appearances.
- Be present for police department visits, appointments with attorneys, or other agencies.
- Serve as a liaison between survivors, law enforcement, county, and community resources.
- Connect survivors with county services.
- Perform follow-up services to ensure that the court order is working for the survivor.
- Facilitate individual and group counseling, crisis counseling and intervention, safety planning, emotional support, and make referrals to trauma-informed domestic violence therapists and/or sexual assault therapists.
- Facilitate training to educate law enforcement and school partners on the scope of services that the domestic violence advocate and sexual assault advocate provide.
- Provide quarterly updates to law enforcement, criminal justice, and schools.



- Network and coordinate the community response to crime victim trauma and improve service delivery by collaborating with other domestic violence and sexual assault support and shelter organizations. Join consultation and community groups such as Violence Free Minnesota the MN Coalition Against Sexual Assault and Family Violence Coordinating Counsel.
- Attend regularly scheduled meetings with other NYFS support staff including the Domestic Violence and Sexual Assault therapists' team.
- Participate in ongoing program development meetings within SV/SA program, including group curriculum development.
- Stay updated on legislative changes and issues within the County and federal government.
- Support NYFS scheduled and drop-in requests for services.
- Document contacts made and all services provided in accordance with NYFS advocacy policy.
- Complete timely all NYFS required forms.
- Continue to update survivors of the progress of their cases.

## **Preferred Education and Experience:**

- BS/BA in Social Work (Masters preferred) coupled with 2 years professional experience.
- Preferred trained in the Safe at Home Protocols and become Safe at Home Certified.
- Familiar with community groups such as Violence Free Minnesota and MN Coalition Against Sexual Assault.
- Proven ability to establish trusting relationships with individuals and families.
- Working understanding of the principles of domestic violence advocacy or sexual assault advocacy within a trauma informed perspective.
- Knowledge of and ability to act as a liaison to connect with county and community resources.
- Skilled in the use of electronic medical records (Procentive preferred).
- Solid understanding of and sensitivity to the cultural and socioeconomic differences among service populations.
- Must have a valid driver's license and personal means of transportation.
